ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act. 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

- 2. AND WHEREAS, the institution Sagar B.Ed College, M.M.Extension, CTS No.777A, Belgaum District - 590001, Karnataka has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed which require additional facilities.
- 3. AND WHEREAS, on scrutiny it is found that the institution has not maintained/revalidated the Fixed Deposited Receipts towards Endowment and Reserve Funds.
- 4. AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely
 - The institution shall submit revalidated FDRs of the enhanced values, in joint account with the SRC before 30 June, 2015 falling which the recognition will be withdrawn.
 - The institution shall create additional facilities that include (a) additional built-up 11: area, (b) additional infrastructure, (c) additional staff as per Regulations. 2014 and inform Regional Committees with required documents by October 31, 2015.
 - The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
 - The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
 - 5. NOW THEREFORE, in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to Sagar B.Ed College, M.M.Extension, CTS No.777A, Belgaum District - 590001, Karnataka for conducting B.Ed programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16 subject to submission of revalidated FDRs of the enhanced value in joint account with the SRC before 30 June, 2015 and fulfilment of the conditions mentioned at II & III herein before 31.10.2015
 - 6. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable Cont 2

- The institution shall, within one month of the receipt of recognition order. convert the Endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee
- The institution shall shift to its own premises / building within three years from the date of recognition. (in case the course is started in rented premises)
- The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the affiliating University, UGC State Government etc.
- The institution shall submit to the Regional Committee a Performance Appraisal 5 Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
- If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act, 1993.

CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely Sagar B.Ed College, M.M. - 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 31.01.2015 & for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 20.05.2015 for conducting B.Ed. courses of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the Southern Regional committee in its 300th meeting held during 29th 31st January, 2016 considered the matter and committee decided to Permit shifting. Accordingly, shifting order was issued to the institution on 17.03.2016 order No.SRO/APS01961/B.Ed /KA/2016/82845 permission is hereby accorded by SRC to Sagar B.Ed College, M.M. Extension, CTS No. 777A, Belgaum District, Karnataka to shift its premises to new location/building at Sagar College of Education, Rs No. 16/1, & 16/2, CTS No. 4125/2B Lakshmi Tekdi, Opp Federal Bank, Ganeshpur Road, Belagavi-590009, Karnataka.
- 4. AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov, 2019 considered the matter and decided to issue SCN u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observation noted by the Regional Committee. Accordingly, a First Show Cause Notice was issued to the institution on 06.11.2019. The institution has not submitted SCN Reply.
- 5. AND WHEREAS, the SRC in its 388th meeting held on 14th-15th September, 2020 considered the matter and decided to issue FSCN u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observation noted by the Regional Committee. Accordingly, a Final Show Cause Notice was issued to the institution on 22.02.2021. The institution has submitted reply vide dated 03.03.2021 & 18.03.2021 in response to the Final Show Cause notice.
- 6. AND WHEREAS, the matter was finally considered the SRC in its 397th meeting held on 25th 26th March, 2021 and the Committee decided as follows: -

- 7. NOW THEREFORE, this order is issued permitting the institution i.e. Sagar College of Education, Survey No. 16/1, CTS No. 4125/2B, Laxmi Tekdi, Ganeshpur, Belagai, Taluk & District-590009, Karnataka run by Dr. Babasaheb Ambedkar Education Society, Kudchi, Raibag District, Belagavi-591311, Karnataka for continuation of recognition for B.Ed. course for two years duration (2 basic units) of 100 students subject to fulfilment of the following conditions:
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 8. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- The institution shall submit to the Regional Committee as Self Appraisal Report at the end
 of each academic year along with the statement of annual accounts duly audited by a Chartered
 Accountant.
- 10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-
 - Sanctioned programme(s) along with annual intake in the institution:
 - Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

 - Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;

- Number of books in the library, journals subscribed to and additions, if any, in the h. last quarter;
- The affidavit with enclosure submitted along with application.
- The institution shall be free to post additional relevant information if it so desires.
- Any false or incomplete information on website shall render the institution liable k. for withdrawal of recognition.
- 11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
